RESOLUTION OF THE TOWNSHIP OF READINGTON, COUNTY OF HUNTERDON, AUTHORIZING AN EMERGENCY APPROPRIATION PURSUANT TO NJSA 40A:4-48 TO FUND THE 2014 BUDGET LINE ITEM-LEGAL SERVICES

WHEREAS, an emergency has arisen with respect to legal services for ongoing litigation and settlement of certain matters and, no adequate provision was made in the 2014 budget for the aforesaid purpose, and NJSA 40A:4-46 provides for the creation of an emergency appropriation for the purpose mentioned above, and

*WHEREAS*, the total amount of emergency appropriations created, including the appropriation to be created by this resolution, is \$395,000.00 and 3% of the total operating appropriations in the budget for 2013 is \$397,241.00,and

**WHEREAS**, the foregoing appropriation together with prior appropriations does not exceed three (3) percent of the total operating appropriations in budget year 2013,

**NOW, THERFORE BE IT RESOLVED**, (by not less than 2/3 of all governing body members affirmatively concurring) that in accordance with NJSA 40A:4-48:

- 1. An emergency appropriation is hereby made for the Legal Services-Other Expenses in the amount of \$395,000.00.
- 2. That said emergency shall be provided for in full in the 2015 budget, and is requested to be excluded from CAPS, pursuant to NJSA 40A:4-53.3c(1).
- 3. That two (2) certified copies of this resolution be filed with the Director of the Division of Local Government Services.
